TRANSFER OF CIVIL AND SMALL CLAIMS ACTIONS FROM WEST JUSTICE CENTER

Pursuant to Rule 10.603(b)(1)(B) of the California Rules of Court, the Superior Court of California, County of Orange, will no longer hear civil and small claims matters in the West Justice Center commencing October 1, 2012.

Hearings Currently Scheduled: All civil and small claims matters scheduled for hearing at the West Justice Center on or after October 1, 2012, will be transferred to the Justice Center listed in the Court Designation List found on the Court's public website (www.occourts.org). Written notice of this location change will be served in each individual case scheduled.

Filing Documents: Effective October 1, 2012, documents for civil and small claims cases will no longer be filed at the West Justice Center. Instead, case documents for civil and small claims actions or proceedings should be filed at the location designated by the current Court Designation List found on the Court's public website (www.occourts.org). Pursuant to Section 402(b) of the Code of Civil Procedure, regardless of where the action or proceeding is filed, the Court may transfer the action or proceeding on its own motion to another Court location for hearing.

Filing Court Locator

Family, Juvenile, Probate, Mental Health Cases, Domestic Violence, Elder Abuse and Dependent Adult Abuse Restraining Orders should be filed at the Lamoreaux Justice Center (LIC).

Small Claims, Limited Civil*, Unlimited Civil*, Complex Civil*, Criminal, Traffic Cases and all Restraining Orders not listed above should be filed pursuant to this Filing Court Locator. Use the city where the action arose or where a defendant resides. If the defendant is a business, use the city where the business is located. If the action concerns real property, use the city where the real property is located.

Criminal and Traffic Cases: Use the city where the offense is alleged to have occurred.
