**MINUTES OF ORANGE COUNTY
JUVENILE JUSTICE COMMISSION
April 5, 2023**

The regular meeting of the Orange County Juvenile Justice Commission was called to order at 9:03 a.m. by Chair Perring. The meeting was held at the Betty Lou Lamoreaux Juvenile Justice Center, 341 The City Drive, Orange, California, in the second floor Commission Conference Room.

APPROVAL OF MINUTES

The March 15, 2023, minutes were approved by unanimous consent.

PUBLIC APPEARANCE

Anthony Kimmerle made an appearance to observe the JJC meeting.

CORRESPONDENCE

The correspondence was reviewed.

NEW BUSINESS

- A. Michael Schumacher – Commissioner Perring informed the commission that Michael Schumacher has resigned as a JJC commissioner.

OLD BUSINESS

A. Narcan Update

Commissioner Johnson reported Narcan is now FDA approved to be an over-the-counter medication. The cost is \$50 for two doses. She mentioned that Alice Kim stated that Narcan is at all STRTPs.

B. YGC Facilities Follow-up

Commissioner Perring provided an overview of the YGC follow-up she had with Martin Corrales, Director of YGC regarding the movement of youth to Juvenile Hall. Commissioner Perring will remain connected to the situation at YGC and will keep the committee informed as to when the youth return to YGC from Juvenile Hall.

C. Food Services Follow-up

Commissioner Perring provided an update of the changes made regarding the food services at Probation. Staff reported that a youth council meeting was held and feedback

regarding the food was provided to the staff. Commissioner Perring reported that Probation ordered food warming carts and have not had any negative feedback thus far.

NEW BUSINESS

A. LA County Juvenile Detention Facilities Update

Commissioner Johnson provided an overview of the article that was written about the LA Juvenile Detention Facilities. Commissioner Johnson said they are experiencing difficulties with their facilities and wanted to bring awareness to the commissioners of the issues. The article mentioned a possible need to transfer 380 youth to surrounding detention facilities.

B. Review Of What to Look for At STRTP Inspections

Commissioner Perring conducted an exercise with the commissioners to target the important factors they see and what youth see as important when inspecting STRTPs. She reminded the group to make notes on the forms and to turn in all forms to the EAA. Commissioner Perring suggested that the commissioners look for and report on areas of concern, areas that need correction and include positive items.

C. Verbal Reports During Meeting

Commissioner Perring suggested that the commissioners make note of anything they feel is of positive or negative significance. She also asked the commissioners to write down items the youth share when being interviewed. The inspection group can decide if they want to have a scribe create a summary.

REPORTS FROM STANDING COMMITTEES & WORKING GROUPS

A. Education – Commissioners Johnson and Vachet mentioned that a meeting has been set for the JJC education committee to meet with Vern Burton on April 25th.

B. JJC/Probation Book Club – Commissioner Lopez provided an update on the book club. Acknowledgement was provided to Silvestre for his work with the youth and the rapport that he has with them. Commissioner Vachet mentioned how Commissioner Lopez is credible and trustworthy with the youth.

C. Law Enforcement Agency Inspections – Commissioner Yost provided a brief update on the LEA inspections. She mentioned that the first LEA inspections have been scheduled and that a minimum of two commissioners are assigned to each inspection.

REPORTS FROM LIAISON ACTIVITIES & WEBINARS

Positive Youth Development Webinar

Commissioners Perring and Yost provided a brief overview of the webinar held on March 16, 2023. Topics discussed were mental health focus, engaging youth and helping to provide social skills to help develop youth strengths.

CCR SOC Meeting

Commissioner Johnson provided an overview of the CCR SOC meeting held on March 23, 2023.

CSEC Steering Committee Meeting

Commissioners Vachet provided a brief overview of the CSEC Steering Committee meeting held on March 23, 2023. Commissioner Vachet stated that the committee is work on setting the tone for the upcoming year. The hope is to work with school districts on a short presentation for the schools.

Juvenile Recovery Court Graduation

Commissioner McClean provided a few positive comments about the Juvenile Recovery Court graduation he and Commissioner Perring attended on March 23, 2023.

JJCC ad hoc meeting

The JJCC ad hoc meeting is tabled to the next JJC meeting on April 19, 2023.

Blue Ribbon Kickoff

Commissioner Perring shared her experience of attending the Blue-Ribbon Kickoff on March 30, 2023. She expressed the impact of child abuse and shared a couple of stories from the event. The kickoff was in recognition of child abuse prevention month.

Substance Abuse Disorder (SUD) subcommittee meeting

Commissioner Johnson provided a brief overview of the SUD subcommittee meeting held on April 4, 2023. She shared that one of the goals was to provide more services to mothers.
